



Youth Group Travel

I understand and acknowledge that North Charlotte Rowing, Inc. d/b/a Belmont Rowing Center ("BRC") is the legal entity that organizes and operates the Activity for and on behalf of Belmont Rowing Center.

I understand that my child's participation in the Activity is a privilege, and not a right. I acknowledge that I have spoken with my child about my child's need to comply with (a) the specific rules and requirements established for this Activity, (b) all BRC policies and procedures and rules of conduct, and (c) all state and federal regulations and laws. I understand that all BRC rules and policies apply to my child and the other youth during the course of the Activity and all related travel.

I understand that private drivers, which may include my child, the parent of another youth participating in the Activity, or a coach, may be used to transport youth to and from the Activity. The owner of the vehicle must carry bodily injury insurance, though BRC does not verify coverage. BRC's insurance does not cover damages arising from, or related to, the operation of any private vehicle (including a coach's private vehicle), failure to follow the directed driving route, or any negligence on the part of the driver or any other individual relating to transportation or overnight stays in connection with this Activity.

I give permission for my child to ride in a vehicle driven by the parent of another youth or a coach to the Activity.

I give permission for my child to ride in a vehicle to and from the Activity with another student.

I give permission for my child to transport students to and from the Activity.

I understand that I have the ability to refuse to sign this Form. In addition, I understand that if I refuse to sign, I will be responsible for any and all transportation required to get by child to the Activity in order to participate in the Activity.

ASSUMPTION OF RISK: I understand that this Activity and the related travel and overnight stay (if any) may expose my child to some risks and I assume any such risk that may arise there from. I accept full responsibility for all medical expenses for any injuries that might occur to my child by reason of their participation.

WAIVER AND RELEASE: By signing this form, I hereby waive and release BRC, its Board of Directors, its Board members, administrators, directors, officers, employees, agents, assigns, and volunteers ("Released Parties") from and against any and all claims, demands, actions, complaints, suits or other forms of liability arising from the transportation of my child to the Activity or from any related travel or overnight stay authorized by me on this form, including but not limited to damages or harm arising from the operation of a motor vehicle by any parent, guardian, coach, student or other designated driver.

By signing this form, I further indemnify and agreed to hold harmless each of the Released Parties (as defined in the preceding paragraph) from and against any and all claims, demands, actions, complaints, suits or other forms of liability (a) arising out of my child's failure to comply with local, state, or federal laws, or with BRC policies, procedures, or code of conduct; (b) arising out of any damage or injury caused by my child, including but not limited to my child's operation of a motor vehicle, if I have authorized my child to drive in connection with this Activity. I also agree to indemnify and hold harmless the Released Parties from all costs, attorney fees, liabilities, settlements, and/or judgments relating to the matters covered by the preceding sentence.

I confirm that I have carefully read this Parental Consent, Release, and Indemnification Form and that I agree to its terms knowingly and voluntarily. I also confirm that I am the parent or legal guardian of the child, or I am a youth 18 years of age or older.
